## **Dine Out With Heart**

The 2020 Dine Out With Heart fundraiser is almost finalized and we are now in the process of advertising our grant applications which are due April 15th, 2020 and can be found on our website:

We have alerted our past receiving non-profits that the proceeds are now ready to disperse, and we are advertising on Facebook and through local non-profit newsletters for any new non-profit that would like to apply. As a reminder, non-profits must use the funds to feed the food insecure in Loveland/Berthoud. The DOWH committee will review applications soon after the deadline and we are planning on dispersing the funds in May. We've been meeting via Zoom to continue this important work and to get the much needed funds into the community as soon as possible.

Overall this year was a challenge with the virus calamity hitting the businesses the beginning of the second week of the fundraiser. Because of this, the businesses only generated \$5,531, with one business proceeds still forthcoming. This amount was the lowest that the fundraiser has ever collected, but thankfully, with our sponsors donating almost \$11,000, the overall funds were almost the same as our best year! The committee will continue to designate funds to the Philo Christmas Food Basket committee per the adopted "DOWH Procedure and Guideline". Currently, we anticipate funding around \$1700 for the Christmas food baskets. These numbers are subject to change, based on determining final fundraiser proceeds. These are very hard times and the committee is doing our best to help as much as we can, as we know Philo in general always does. **Golf Tournament:** The plan is still to have the golf tournament on Friday, June 26 and do the best we can. So far, understandably, no golfers have signed up. We have approximately \$3,000 in sponsorship.

A lot depends on the next few weeks - like when the golf course will reopen. It's currently closed until April 26. Cindy and Denise are sure attendance will be impacted. They are hoping to get 40 - 60 golfers and a couple more thousand in sponsorship.

The sponsor money goes directly toward scholarships. The golfers' fees are for the course and the food (generally speaking) so we should be able to handle the potential downsize of attendance. We doubt we will get many gift cards or business gifts to hand out as prizes since those businesses are severely impacted due to the virus. We hope Philo members step up to donate gift baskets for the raffle and prizes. We do not plan to have a 'cart gift' for each golfer to save on cost. We think we can use past gifts that are in inventory at Peg Isakson's house.

**Currently, there is not a Chair or Co-chair for next year's golf tournament.** So, this may be the last year for the tournament as Cindy and Denise will not chair it again. (They will be members if a Chair and co-chair step forward.) Therefore, they think it's a good idea to use up the leftover gift inventory and not accumulate more items.

**Integrated Early Childhood:** We purchased a total of 272 books for schools with just under \$1500 from the book fair and a gift card from RB&B Architects (Brianna Smith). All were delivered to the Early Childhood Program at Stansberry School in early March. We also delivered 16 weighted lap pads to Stansberry and Monroe. All were greatly appreciated.

Our last event of the year would have been the literacy fair which was cancelled due the school closures. Next year Cheryl Hitchens will take over as chairwoman. The ladies of this committee have been fantastic to work with these last few years. Thanks to all of you.

## Publicity: Nothing to report

**Duck Race:** Loveland Rotary Club printed the Duck Race tickets in January instead of March. With the coronavirus, it proved to be fortunate. We were able to sell tickets (7 for \$20) at the January, February, and March Philo meetings. Since Philo meetings were canceled, we have accepted sales by phone and mail. Although we had a head start, sales were disappointing. We hoped to exceed our goal of 60 sets but have fallen well short of that at 45 sets. Rotary generously allows us to keep 80% of sales—the most of any organization they work with. As it stands at this time (April 10), we will add \$720 to the club operations budget instead of the hoped for \$960. This will impact the budget significantly since the other fund raiser, Fall Shopping Extravaganza, was canceled this year. We will continue to reach out to Philo members to purchase tickets before our deadline in July.

Scholarships: Application deadline has been changed to April 28 due to Coronavirus.

**Spring Social:** The 2019 Spring Appreciation Social has been cancelled and plans have been made to recapture our need to celebrate. We will schedule September 10, 2020 (Thursday) 5:30 P.M at High Country Beverage as a modified celebration with no cost to members. The event will include installation of officers and new members.
