This is a summary of the proposed changes to the by-laws.
The entire by-laws were published in the March newsletter.

REVISIONS TO THE PROPOSED PHILO BYLAWS

At our March 11 meeting, Mary Voggesser reviewed the proposed changes to the Philo bylaws. The changes reflect the recommendations of the Task Force and discussion with the board and membership. The following is a summary of changes:

- Remove language regarding the cap on membership and chronological listing of prospective members
- Add an organizational meeting in June for transition to new committees and to prepare for summer events
- Adjust the Philo membership year to begin on June 1 with officers and committees assuming their responsibilities
- Remove the Historian from the Board and create a committee to maintain the historical records and act as photographers
- Change the Executive Board to include the Past President
- Change the responsibilities of the Vice President
 - Change responsibility for the yearbook to chairing a Yearbook Committee
 - Move maintaining the nomination list of prospective new members to the Corresponding Secretary
- Change the responsibilities of the Recording Secretary
 - Add responsibility for name tags
 - Add responsibility for maintaining the membership list.
- Change the responsibilities of the Corresponding Secretary
 - Add maintaining the nomination list of prospective new members and creating the membership packets
 - Mail membership invitations the day after balloting

Several items were corrected/changed during the March 11 review:

Article IV, Membership

- E. The Philo year for attendance records shall run from [June 1 to May 31](#).

Article VII, Officers

Section 1. Elected Officers

- A. The elected officers shall be: President, Vice President, Recording Secretary, Treasurer, Corresponding Secretary, and [Past President](#).

Section 2. Term of Office

- A. The elected officers shall be installed at the meeting in May and assume their responsibilities on [June 1](#).

Article IX, Executive Board

Section 1. Composition

- A. The executive board shall be made up of the President, Vice President, Recording Secretary, Corresponding Secretary, and [Past President](#).
