## PHILO GENERAL MEETING MINUTES

## September 11, 2012

A reception was held prior to the General Meeting to honor the new scholarship recipients. Refreshments were provided by the hostesses Marilyn Wiltgen, Lin Stokes, Amy Hummel and the Scholarship Committee.

Scholarship Committee Chair, Diane Bakel, welcomed the guests. Each scholarship recipient was assigned a committee member to welcome them at the door and introduce them: Kyle Sommers (Mary Ann Lane), Shawnee Lousberg (Florence Doksansky), Kaitlyn Weber (Shellie Gutierrez), Barbara Hoffman (Bonnie Hanson), Michelle Miller (Kathy Loken), Traci Miller (Karen Sanders), Lucas Isakson (Karen Sanders), Danielle Randolph (DeeDee Warnock), Tonya Heinzen (Lin Stokes). President Sheila Pottorff called the meeting to order after a brief recess. There were 53 members present, 39 active and 14 honorary members.

Sheila spoke about the importance of friendship, one of the six characteristics in Philo's motto. She read a poem about friendship and urged us to develop friendships within the club. She led us in a moment of silence for club members who have suffered losses recently and in remembrance of the lives lost on September 11, 2001.

## OFFICER REPORTS:

Treasurer, Peggy Pellizzari, presented the proposed budget for 2012/2013. She explained how the budget was balanced and why some changes were made. Miki Roth commented on the decision to drop the Chamber of Commerce membership. While we have not received any significant benefits in the last two years, we could make valuable connections to business people if we made an effort to attend the After Hours events. If business people knew more about Philo, they might be more interested in supporting our fund raisers. The budget will be voted on at the October meeting.

Peggy reported a General Fund balance of $\$ 15,770$ and a Golf Fund balance of $\$ 18,489.48$. Some of the scholarship money has not yet been disbursed.

Vice-President, Heather Morrison, asked members to check off their names as they take a copy of the new yearbook.

She introduced new members who were inducted in May: Jennifer Bao, Linda Hollingsed, Ruth Sprain, and Vicki Thompson.

Heather joined with Historian, Juanita Cisneros, to initiate our Barbie Make-Over project. From our storage unit, Juanita discovered several Barbie dolls that were dressed to represent the various Philo committees. These Barbies were presented to the current committee chairs with the challenge of making them over to reflect current times. The Barbie Make-Over Reveal will take place at the Christmas party.

Historian, Juanita Cisneros, reported that photos have been taken at the Early Childhood committee's box assembly, the Corn Roast Parade, the Cherry Pie Festival, the Philo Golf Scramble, and tonight's Scholarship Recipient Reception.

Christmas trees from the Holiday Boutique are available for free. Those left will be donated to ARC.
As a new feature, "This Date in Philo," Juanita read an article describing a Philo meeting from September 1950. The theme was Russia and involved some singing and dancing.

Corresponding Secretary, Pam Pellizzari, reported that the Board regretfully accepted four recent resignations: Carol Albers, Diane Dynes, Connie Ephland, and Carol Helzer.

Several pieces of correspondence from scholarship recipients have been received and are available to read at the Board table.

Pam is in charge of the badges. Let her know of any that need repair.
Recording Secretary, Linda Stangel, asked for approval of the April minutes. A motion, made by Mary Voggesser and seconded by Trudy Eckhardt, was approved.

Members were reminded to check their names on the attendance list. Anyone who is having difficulty making the meetings on a regular basis should contact someone on the Board. This is especially true if there is some way that we may help.
